RULES FOR CHILI COMPETITION

- 1. Head cook or designee must register on the Registration Form for chili cook-off.
- 2. You can enter more than 1 chili if you wish. Entry fee is \$25 for 1 entry. \$15 for each additional chili entered. Contest is limited to the first 30 entries.
- 3. Chili Entry tables can begin setting up at 3:00 pm on Saturday, February 8, 2020
- 4. Teams are responsible for supplying all ingredients, cooking devices, serving utensils, towels, **extension cords, surge protectors**, etc.
- 5. Harmony House will provide sampling cups, spoons, and bowls, and chili condiments.
- 6. Each team will be allocated one half of table within the Elberton Civic Center.

PREPARING CHILI

- 1. Each contestant/team must prepare a minimum of 8 quarts of competition chili (enough to fill 2 average crock pots).
- 2. Chili must be warm and ready to serve by 4:00 pm.
- 3. Teams may bring all garnishes normally served with your chili. Harmony House will provide shredded cheese and sour cream at a central condiment table.

JUDGING OF CHILI

- 1. A total of three judges will judge entries for the following on a scale of 1 to 5
 - 1. Flavor
 - 2. Texture and consistency
 - 3. Aroma
 - 4. Uniqueness
- 2. Judging will be on score cards, which are numbered. Each team will be assigned a number upon check-in.
- 3. The highest rated vote getters will be awarded Winner in four placements 1st, 2nd, 3rd Place (Judge awarded) and "People's Choice" (People's choice awarded by attendee ballot)
- 4. In the event of a tie, the judges will re-taste and cast a tie-breaker vote. The decision of the judges is final.
- 5. Judging will be between 5:00 and 5:30 pm.
- 6. Awards will be presented at 5:45 pm.

TASTING OF CHILI

- 1. Attendees will be admitted for tasting beginning at 4:00pm.
- 2. Cost to sample all entries of chili is \$5.00/person (Admission fee for event).
- 3. Individual bowls of chili will be available to purchase for \$1.00/bowl. Soft drinks, bottled water and sweets will also be available for purchase.

CLEANING UP

- 1. Contestants/teams shall be responsible for leftover chili.
- 2. Booth cleanup begins at 6:00 pm.
- 3. Booths may not be disassembled until the event closes to the public.
